→違規者處新臺幣1,200元至3,600元罰鍰

滿 14歲

未滿14歲者駕駛微型電動二輪車

→處駕駛人新臺幣600元至1,200元罰鍰，
並禁止駕駛、車輛移置保管





สิ่งที่ต้องทำก่อนขับขี่ รถจักรยานไฟฟ้า

ทำประกัน

เจ้าของรถทุกคนต้องซื้อประกันภาคบังคับ
กับบริษัทประกันภัย

→ ผู้ไม่ทำประกันจะไม่สามารถยื่นขอหรือเปลี่ยนแผ่นป้ายทะเบียนรถได้

ติดป้าย
ทะเบียน

หลังผ่านการตรวจสอบต้องยื่นจดทะเบียน
และติดแผ่นป้ายทะเบียนรถ

→ หากฝ่าฝืนต้องระวางโทษปรับ 1,200 - 3,600 บาท หรือ คุก 1 เดือน

อายุครบ
14 ปี

ผู้ขับขี่รถจักรยานไฟฟ้าที่อายุไม่ครบ 14 ปี

→ ต้องระวางโทษปรับ 600-1,200 บาท หรือ คุก 1 เดือน และจะถูกห้ามขับขี่รวมถึงจะถูกยึดรถไว้ชั่วคราว





Kendaraan Roda Dua Listrik Mikro

Hal-hal yang wajib dilakukan sebelum mengendarainya

Asuransi

Setiap orang harus mengajukan asuransi kendaraan wajib kepada perusahaan asuransi

→ Bagi yang tidak mendaftarkan asuransi, maka tidak dapat mengajukan pendaftaran, penggantian atau penerbitan lisensi

Pelat Nomor

Bagi mereka yang lolos pemeriksaan, maka harus mendaftar ke unit kendaraan bermotor untuk memperoleh pelat nomor, kemudian menggantungnya di tempat semestinya

→ Pelanggar akan dikenakan denda NT\$ 1.200 hingga NT\$ 3.600

Genap Berusia 14 Tahun

Bagi yang belum genap berusia 14 tahun, mengendarai kendaraan roda dua listrik mikro

→ Pengemudi akan dikenakan denda NT\$ 600 hingga NT\$ 1.200, serta dilarang mengendarai dan kendaraan bersangkutan akan direlokasi dan ditahan.





Xe máy điện hai bánh loại nhỏ Những việc phải làm trước khi lưu thông trên đường!

Mua bảo
hiểm

Chủ xe cần tự mua bảo hiểm trách nhiệm pháp lý bắt buộc với xe mô-tô từ các công ty bảo hiểm

→ Người không có bảo hiểm không thể đăng ký, đổi hoặc cấp giấy đăng ký xe.

Gắn biển
số

Sau khi kiểm tra đạt tiêu chuẩn sẽ được đăng ký với đơn vị đăng kiểm, nhận và gắn biển số xe.

→ Người vi phạm sẽ bị phạt từ 1.200 - 3.600 Đài tệ

Đủ 14
tuổi

Người dưới 14 tuổi điều khiển xe máy điện hai bánh loại nhỏ thì:

→ Người điều khiển xe sẽ bị phạt từ 600 - 1.200 Đài tệ, bị cấm lái xe, phương tiện sẽ bị tịch thu và cất giữ.





Before driving a mini electric two-wheel vehicle in public you must first be in compliance with the following

Insurance

Vehicle owners are required to take out compulsory auto liability insurance with a property insurance company

→ without insurance it is impossible to register a renewed license or issue a license.

Attach a license plate

Owners of vehicles that pass a safety test are required to register with a Motor Vehicle Office, pick up and affix a license plate.

→ Anyone in violation of this provision can be fined NT\$1,200 to NT\$3,600

14 years old and above

Anyone under the age of 14 found driving a mini electric two-wheel vehicle

→ can be fined NT\$600 to NT\$1,200, banned from driving and have their vehicle impounded.
