แรงงานกึ่งฝีมือ

สามารถเปลี่ยนนายจ้างใหม่ได้ไหม?

เปลี่ยนได้! กฎระเบียบในการเปลี่ยนนายจ้างใหม่ของแรงงานกึ่งฝีมือเช่นเดียวกับแรงงานต่างชาติทั่วไป เพียงแค่มีคุณสมบัติดังนี้ :

- แรงงานกึ่งฝีมือ นายจ้างเก่าและนายจ้างใหม่ ตกลงยินยอมกันทั้ง 3 ฝ่าย
- กรณีที่ความผิดไม่ได้เกิดจากแรงงานกึ่งฝีมือ และได้รับอนุญาตให้เปลี่ยนนายจ้างใหม่ได้
- เปลี่ยนนายจ้างใหม่เมื่อครบกำหนดสัญญาจ้าง

Tenaga Kerja Terampil Menengah Juga bisa pindah majikan?

Bisa! Peraturan terkait untuk pengajuan pindah majikan bagi tenaga kerja terampil menengah sama seperti peraturan yang berlaku pada pekerja migran, asalkan memenuhi persyaratan berikut:

- Kesepakatan dari tiga pihak yaitu tenaga kerja terampil menengah, majikan awal dan majikan baru
- Keadaan yang tidak disebabkan oleh orang asing yang telah mendapatkan izin
- Selesai kontrak pindah majikan

Nhân lực kỹ thuật trình độ trung cấp cũng được đổi chủ à?

Được chứ. Các quy định liên quan về việc xin đổi chủ đối với lao động có kỹ năng trình độ bậc trung giống như các quy định hiện hành đối với lao động nhập cư, chỉ cần đáp ứng các điều kiện sau:

- Lao động có kỹ năng trình độ bậc trung, chủ cũ, chủ mới, ba bên đồng ý chuyển đổi.
- Người được phép đổi chủ vì lý do không thuộc trách nhiệm của bản thân người lao động.
- Đổi chủ khi hết hạn hợp đồng.

Can **Intermediate skilled workers** also transfer employers?

Yes. The regulations governing applications by intermediate skilled workers to transfer employer are the same as current regulations on the transfer of foreign workers. One of the following conditions must be met:

- The intermediate skilled worker, original employer and new employer agree to a transfer**
- The reason for the approved transfer cannot be attributed to the foreign worker**
- When it is a contract completion transfer**
