## 提醒重點

### POINT 01

### 海關徵收稅金一定會開立稅單

稅單上有稅單號碼或報單號碼，海關不會以轉入私人帳戶、刷卡或比特幣等方式收取稅款！



有疑問時，請收款方出具稅單紙本或提供稅單號碼、報單號碼後，電洽各地海關：

### POINT 02

### 包裹在完成通關流程後 才會核發稅單

若是報關資格不符、文件不齊，海關不可能預先收取稅金。

例如，價值美金5000元以上的包裹必須正式報關，在完成通關前不會產生稅單，也不會通知繳稅。

若是您被告知即將收到價值美金5000元以上的包裹並須收取稅金，但您未曾進行過正式報關，這樣幾乎能肯定是遇到詐騙集團了。



### POINT 03

### 以國際快遞寄送的包裹

若包裹價值台幣5萬元以下，且包裹內容物不涉及輸入規定(管制輸入或須經核可才能輸入)  
可下載EZWay 易利委 app掌控包裹通關流程。

## หัวข้อสำคัญในการแจ้งเตือน

### POINT 01 ในการเรียกเก็บภาษีของกรมศุลกากร จะต้องมีการออกใบกำกับภาษีอย่างแนบ

บนใบกำกับภาษีจะระบุหมายเลขใบกำกับภาษีหรือหมายเลขใบขน กรมศุลกากร  
จะไม่เรียกเก็บเงินภาษีโดยวิธีการโอน**เข้าบัญชีส่วนบุคคล จ่ายด้วยบัตรเครดิตหรือ  
เหรียญบิทคอย**



หากมีข้อสงสัย โปรดติดต่อกรมศุลกากรในแต่ละพื้นที่

หลังจากให้ผู้รับเงินออกเอกสารใบกำกับภาษีหรือให้หมายเลขใบกำกับภาษี หมายเลข

### POINT 02 พัสดุจะอนุมัติออกใบกำกับภาษีหลังจากผ่าน ขั้นตอนพิธีการทางศุลกากรแล้ว

กรมศุลกากรจะไม่เรียกเก็บภาษีส่งหน้าหากไม่สอดคล้องกับเงื่อนไข  
พิธีการศุลกากรหรือเอกสารไม่ครบถ้วน

ตัวอย่างเช่น พัสดุที่มีมูลค่า 5000 ดอลลาร์สหรัฐขึ้นไปจะต้องดำเนินพิธีการทางศุลกากร  
อย่างเป็นทางการ ก่อนจะเสร็จสิ้นพิธีการศุลกากรจะไม่มีใบกำกับภาษีเกิดขึ้น และจะไม่มี  
การแจ้งให้ชำระภาษี หากคุณได้รับการแจ้งว่ากำลังจะได้รับพัสดุที่มีมูลค่า 5000  
ดอลลาร์สหรัฐขึ้นไปและจะต้องเรียกเก็บภาษี **โดยที่คุณยังไม่เคยดำเนินพิธีการทาง  
ศุลกากรอย่างเป็นทางการ** ในกรณีนี้คุณคงจะเจอกับกลุ่มมิจฉาชีพฉ้อโกงแล้ว



### POINT 03 พัสดุที่**ส่งด่วน**ระหว่างประเทศ

หากพัสดุมูลค่าต่ำกว่า 5 หมื่นเหรียญได้ทุกวัน และสิ่งของภายใน  
พัสดุไม่เกี่ยวข้องกับข้อกำหนดในการนำเข้า

(ควบคุมการนำเข้าหรือนำเข้าหลังจากได้รับอนุมัติ)

# Penyuluhan Pencegahan Penipuan Paket Internasional



## Poin Penting Peringatan

### POINT 01

### Bea cukai memungut pajak pasti akan mengeluarkan tagihan pajak

Pada tagihan pajak ada nomor tagihan pajak atau nomor pelaporan pajak, bea cukai tidak akan menggunakan cara **transfer ke rekening pribadi, kartu kredit atau Bitcoin** untuk memungut uang pajak.



Sewaktu ada pertanyaan, silakan meminta pihak penerima pembayaran menerbitkan lembaran tagihan pajak atau memberikan nomor tagihan pajak, nomor pelaporan pajak, menelepon bea cukai di berbagai tempat:

Bea Cukai Taipei: 03-383-4265  
Bea Cukai Kaohsiung: 07-561-3251

### POINT 02

### Setelah paket menyelesaikan proses pabeaan baru akan diterbitkan tagihan pajak

Bila syarat pelaporan bea cukai tidak sesuai, dokumen tidak lengkap, bea cukai tidak mungkin memungut pajak di muka.

Misalnya, paket dengan nilai di atas US\$ 5.000 harus dilaporkan ke bea cukai secara resmi, sebelum menyelesaikan proses pabeaan, tidak akan dibuat tagihan pajak, juga tidak akan memberitahukan untuk membayar pajak. Bila Anda diberitahukan akan menerima paket dengan nilai di atas US\$ 5.000 dan harus dipungut pajak, **namun Anda belum pernah melakukan pelaporan bea cukai secara resmi, hampir bisa dipastikan Anda bertemu dengan grup penipuan.**



### POINT 03

### Paket yang dikirimkan dengan kurir internasional

Bila nilai paket di bawah NT\$ 50.000, dan isi paket tidak terlibat dalam peraturan impor (impor yang dikendalikan atau perlu persetujuan baru bisa mengimpor)

**Bisa mengunduh aplikasi EZWay untuk mengontrol proses pabeaan.**

# Tuyên Truyền Phòng Chống Lừa Đảo Qua Kiện Hàng Quốc Tế



## Nhắc trọng điểm

### POINT 01 Hải quan chung thu tiền thuế nhất định sẽ kê khai Đơn thuế

Trên Đơn thuế có mã số Đơn thuế hoặc mã số Đơn báo thuế, Hải quan chung thu tiền thuế theo phương thức chuyển **vào tài khoản riêng, quét thẻ hoặc Bitcoin.**

Khi có thắc mắc, vui lòng sau khi nhận được tờ Đơn báo thuế hoặc mã số Đơn thuế, mã số Đơn báo thuế, gọi điện cho Hải quan các khu vực :

Hải quan Đài Trung: 04-2656-5101	Hải quan Cao Hùng: 07-561-3251

### POINT 02 Kiện hàng sau khi hoàn thành quy trình thông quan mới được phát Đơn thuế

Nếu thông tin khai báo không khớp, văn bản không đầy đủ, Hải quan không được thu trước tiền thuế.

Ví dụ, kiện hàng trên 5000 đô-la Mỹ nhất định phải khai báo Hải quan chính thức, trước khi hoàn thành thông quan sẽ kê khai Đơn thuế, cũng không thông báo nộp thuế. Nếu bạn được thông báo sẽ nhận được kiện hàng trên 5000 đô-la Mỹ thì phải phải thu tiền thuế, **nhưng bạn chưa từng tiến hành khai báo Hải quan chính thức nào, như vậy gần như có thể khẳng định là đã gặp phải Tập đoàn lừa đảo.**

### POINT 03 Kiện hàng gửi phát nhanh quốc tế

Nếu kiện hàng có giá trị dưới 50 nghìn Đài tệ, và đồ gửi bên trong không liên quan đến quy định nhập khẩu (quản chế nhập khẩu hoặc phải được hạch chuẩn mới được nhập khẩu),

**có thể tải app EZWay để nắm bắt quy trình thông quan kiện hàng.**

# 01

## Ang koleksyon ng buwis sa customs ay **siguradong maglalabas ng mga bayarin sa buwis**

Ang bayarin sa buwis ay may tax bill number o declaration number, ang Customs ay hindi mangongolekta ng mga buwis sa pamamagitan ng **paglipat sa mga pribadong account, card swipe o Bitcoin.**

Kapag may pag-aalinlangan, hilingin sa nangongolekta na mag-isyu ng papel na bayarin sa buwis o magbigay ng tax bill number, declaration number, at mangyaring makipag-ugnayan sa lokal na customs sa pamamagitan ng telepono:

### POINT

# 02

## Ang bayarin sa buwis ay **ibibigay lamang matapos makumpleto ang pagproseso ng pakete sa customs clearance**

Kung ang deklarasyon ng customs ay hindi kwalipikado, at ang mga dokumento ay hindi kumpleto, ang customs ay hindi maaaring mangolekta ng paunang bayad ng buwis.

Halimbawa, ang mga pakete na may halagang higit sa US\$5,000 ay dapat pormal na ideklara sa customs, at walang singil sa buwis na bubuo hanggang sa makumpleto ang customs clearance, at wala rin abiso sa pagbabayad ng buwis. Kung sinabihan ka na makakatanggap ka ng pakete na nagkakahalaga ng higit sa US\$5,000 at napapailalim sa mga buwis, **ngunit hindi ka pa nakagawa ng pormal na deklarasyon sa customs, halos tiyak na nakatagpo ka ng isang grupo ng scam.**



### POINT

# 03

## Ang mga pakete na ipinadala sa **international express**

Kung ang halaga ay mas mababa sa NT\$50,000 at ang mga nilalaman ng pakete ay hindi nasasangkot ng mga regulasyon sa pag-import (kinokontrol ang pagpasok o kinakailangan ang pag-apruba upang makapasok)

**Maaaring i-download ang EZWay app para masubaybayan ang pagproseso ng pakete sa customs clearance.**

# International Parcel Anti-Fraud Advocacy



## Specially Mentioned

### POINT 01 **The Customs will usually issue a tax bill for tax collection.**

The serial number or the customs declaration number will be printed on the tax bill. The Customs will not collect tax **through a personal bank account, by credit card charge or Bitcoin.**



Should you have any query, ask the receiving side to present the tax bill in hard copy, or the serial number or quotation number of the bill and contact the offices of the Customs in the district:

### POINT 02 **Tax bill on parcels will be issued only after customs clearance.**

If the parcel in point is not eligible for customs clearance or not all the required documents are in place, the Customs will not collect tax in advance.



For example: parcels at the value of US\$5,000 or above must be officially declared. No tax bill will be generated before customs clearance. You will not be notified to pay tax. If you are told a parcel at the value of US\$5,000 or higher will be delivered to you and tax will be collected, **but you have not yet officially declared with the Customs, you are highly likely be the target in the scam of the the fraud gang.**

### POINT 03 **Parcels delivered via intentional courier service**

Parcels at the value of NT\$50,000 or less and the content of which is not subject to import control

(restricted for import or an import permit is required)

**Could pass through the customs procedure with the EZWay app from download.**
