เมื่อมีการเปลี่ยนแปลงสถานที่พักแตกต่างไปจากที่ระบุในแผนบริหารและดูแลแรงงานต่างชาติ นายจ้างจะต้องแจ้งสถานที่พักใหม่
ต่อกองแรงงานห้องที่ **ภายในเวลา 7 วัน** นับจากวันเปลี่ยนแปลง

กระทรวงแรงงานผ่อนปรนวิธีการแจ้ง ไม่จำกัดเฉพาะยื่นขอเป็นเอกสาร
อนุญาตให้ทำเรื่องผ่านระบบออนไลน์ได้

Majikan (Agensi) Menangani Pengajuan Perubahan Tempat Tinggal Pekerja Migran yang Direkrut

Dapat Diajukan Secara Online!

Sesuai dengan perencanaan layanan perawatan warga asing, jika majikan hendak mengubah tempat tinggal Pekerja Migran, maka **7 hari setelah dilakukan perubahan** harus segera melaporkan kepada otoritas kompeten di mana Pekerja Migran bersangkutan tinggal atau bekerja.

Kementerian Ketenagakerjaan mempermudah metode pelaporan. Tidak terbatas pada layanan tertulis, pengajuan juga dapat dilakukan secara online

thay đổi nơi cư trú của người lao động

CÓ THẺ NỘP HỒ SƠ TRỰC TUYẾN

Nếu có bất kỳ thay đổi nào về nơi ở của người lao động nước ngoài, chủ thuê phải thông báo cho cơ quan có thẩm quyền địa phương nơi người lao động nước ngoài làm việc hoặc sinh sống **trong vòng 7 ngày sau khi thay đổi địa chỉ.**

Bộ Lao động nói lỏng cách thức thông báo, không giới hạn nộp văn bản trực tiếp, có thể nộp hồ sơ trực tuyến.

Employers (labor brokers) can apply online

to change the location of accommodation provided to foreign workers they hire

When an employer changes the location of accommodation detailed in the Foreign Worker's Care Service Plan, the local competent authority in the area where the foreign workers live or work must be informed within seven days of the change being made.

The Ministry of Labor has relaxed regulations on notifications so they can now be made through an online application rather than only in writing.
