依據就業服務法規定，移工在臺灣工作有期間限制

**產業移工/  
機構看護工**

**累積不得逾12年**

**家庭看護工**

**經專業訓練或自立學習，符合中央主管機關所定  
資格條件者，累積不得逾14年**

若工作年限即將屆滿，移工仍想繼續留臺工作，可確認自身是否符合「中階技術人力」申請資格。若符合資格則可透過雇主申請轉任為中階技術人力，即可不受移工工作年限的限制喔！

# แรงงานต่างชาติที่มาทำงานในไทยวัน

**มีการจำกัดระยะเวลาทำงานหรือไม่?**



ตามกฎหมายการจ้างงานกำหนด มีการจำกัดระยะเวลาการทำงานในไทยวันของแรงงานต่างชาติ

แรงงานต่างชาติภาคการผลิต/  
ผู้อนุบาลในองค์กร

ระยะเวลาทำงานสะสมไม่เกิน **12 ปี**

ผู้อนุบาลในครัวเรือน

หลังผ่านการฝึกอบรมเสริมทักษะหรือฝึกฝนด้วยตนเอง  
สอดคล้องกับเงื่อนไขของหน่วยงานผู้ทรงอำนาจส่วนกลาง  
มีระยะเวลาทำงานสะสมไม่เกิน **14 ปี**

กรณีใกล้ครบกำหนดเวลาที่จำกัด แรงงานต่างชาติที่ต้องการอยู่ทำงานในไทยวันต่อไป  
สามารถตรวจสอบคุณสมบัติของตนเองว่าสอดคล้องกับเงื่อนไขการยื่นขอระดับเป็น  
“แรงงานกึ่งฝีมือ” หรือไม่

ผู้มีคุณสมบัติสอดคล้องกับเงื่อนไขสามารถยื่นระดับเป็นแรงงานกึ่งฝีมือได้โดยให้นาย  
จ้างช่วยยื่นขอซึ่งจะช่วยให้ไม่ถูกจำกัดระยะเวลาการทำงานในไทยวันอีกต่อไป!



Dengan status pekerja migran bekerja di Taiwan

apakah ada batasan masa kerja?



Merujuk pada peraturan layanan ketenagakerjaan,  
terdapat batasan masa waktu kerja pekerja migran yang bekerja di Taiwan

Pekerja migran sektor manufaktur/  
perawat lembaga perawatan

**Kumulatif tidak boleh melebihi 12 tahun**

Perawat sektor rumah tangga

Melalui pelatihan profesional atau otodidak,  
memenuhi persyaratan kualifikasi yang ditetapkan otoritas  
kompeten pusat: Kumulatif tidak boleh melebihi **14 tahun**

Apabila masa kerja akan segera berakhir sementara pekerja migran masih ingin meneruskan bekerja di Taiwan, Anda dapat memastikan apakah Anda memenuhi kualifikasi untuk mengajukan permohonan menjadi “Tenaga kerja teknis menengah”. jika memenuhi kualifikasi, maka dengan pengajuan peralihan status menjadi tenaga kerja teknis menengah oleh majikan, Anda bisa segera dibebaskan dari batasan tahun kerja dari pekerja migran!

# Đi làm việc tại Đài Loan theo diện lao động nhập cư có giới hạn thời gian không?



**Theo luật dịch vụ việc làm,  
người lao động nhập cư bị giới hạn thời gian làm việc tại Đài Loan**

Lao động nhập cư trong ngành công nghiệp/  
nhân viên chăm sóc tại cơ sở

**tổng cộng không được quá **12 năm**.**

Lao động nhập cư làm việc tại gia đình

Sau khi được đào tạo chuyên môn hoặc tự học, những người đáp ứng các yêu cầu về trình độ do cơ quan có thẩm quyền trung ương quy định, không được quá **14 năm**.

Nếu sắp hết thời gian lao động mà bạn vẫn muốn tiếp tục làm việc tại Đài Loan, Bạn có thể xác nhận xem mình có đủ điều kiện để đăng ký “Nhân lực kỹ thuật bậc trung” hay không.Nếu đáp ứng đủ điều kiện, bạn có thể đăng ký chuyển sang nhân lực kỹ thuật bậc trung thông qua người sử dụng lao động, là có thể miễn hạn chế về số năm làm việc của người lao động nhập cư!

# Is there a limit to the time foreign nationals can work in Taiwan?



**According to the provisions of the Employment Service Act,  
there are limits to the maximum period of time  
foreign nationals are allowed to work in Taiwan**

**Industrial foreign workers/  
institutional care workers**

**Maximum of 12 years**

**Live-in care workers**

**Individuals who have received professional training  
or undertaken self-study and meet the qualifications  
stipulated by the Central Competent Authority can work  
for a maximum of 14 years**

If a foreign worker's period of work in Taiwan is about to reach the statutory limit and he or she wishes to continue working in the country, first determine whether they are eligible to be re-designated as an “**intermediate skilled worker**”.

If a worker is eligible, their employer can apply for them to be re-designated an intermediate skilled worker, as such workers are not subject to limits on the amount of time they can work in Taiwan.
