

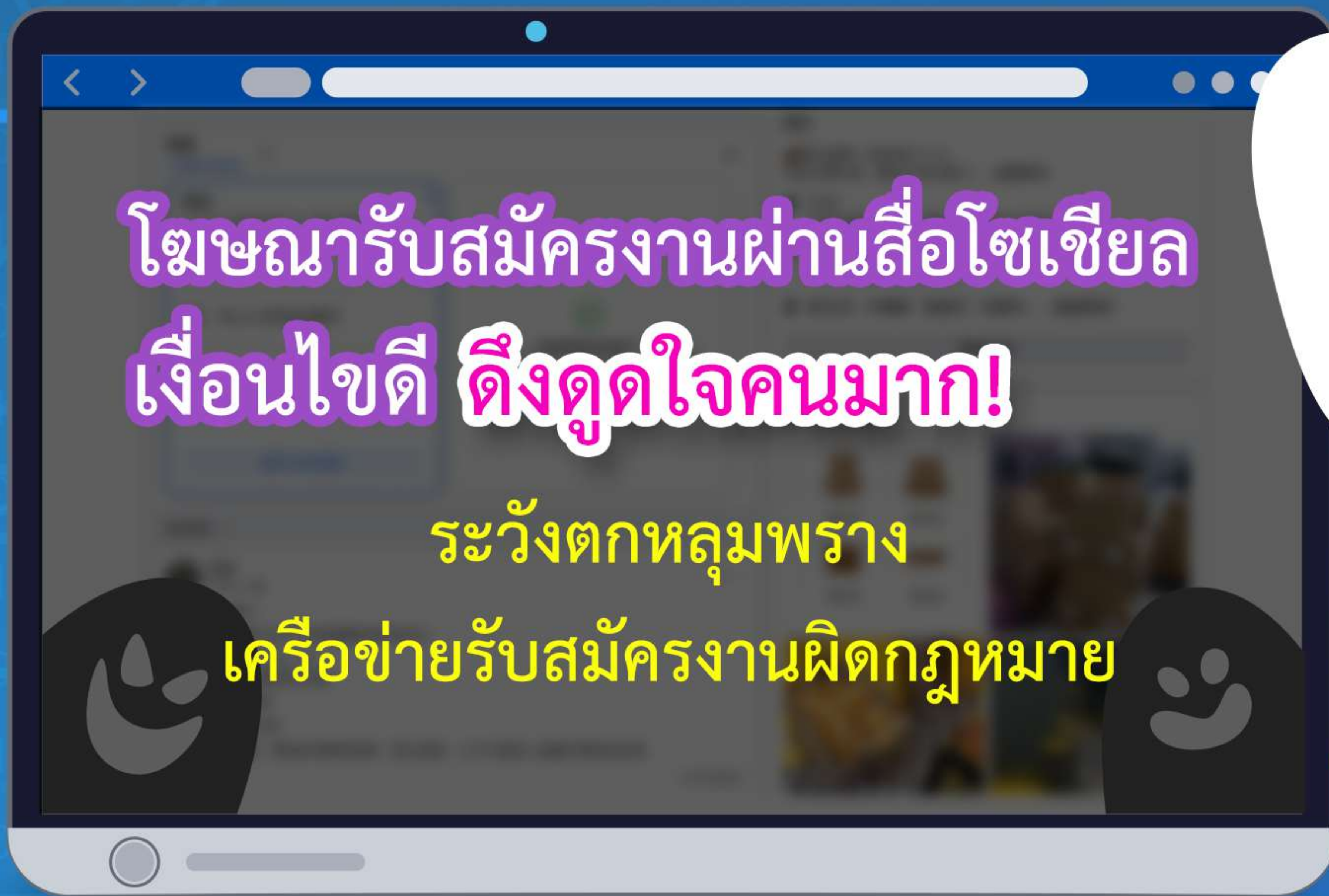
# 社群招募工作貼文的 職缺條件讓人好動心？

## 當心落入 地下求職網路的陷阱

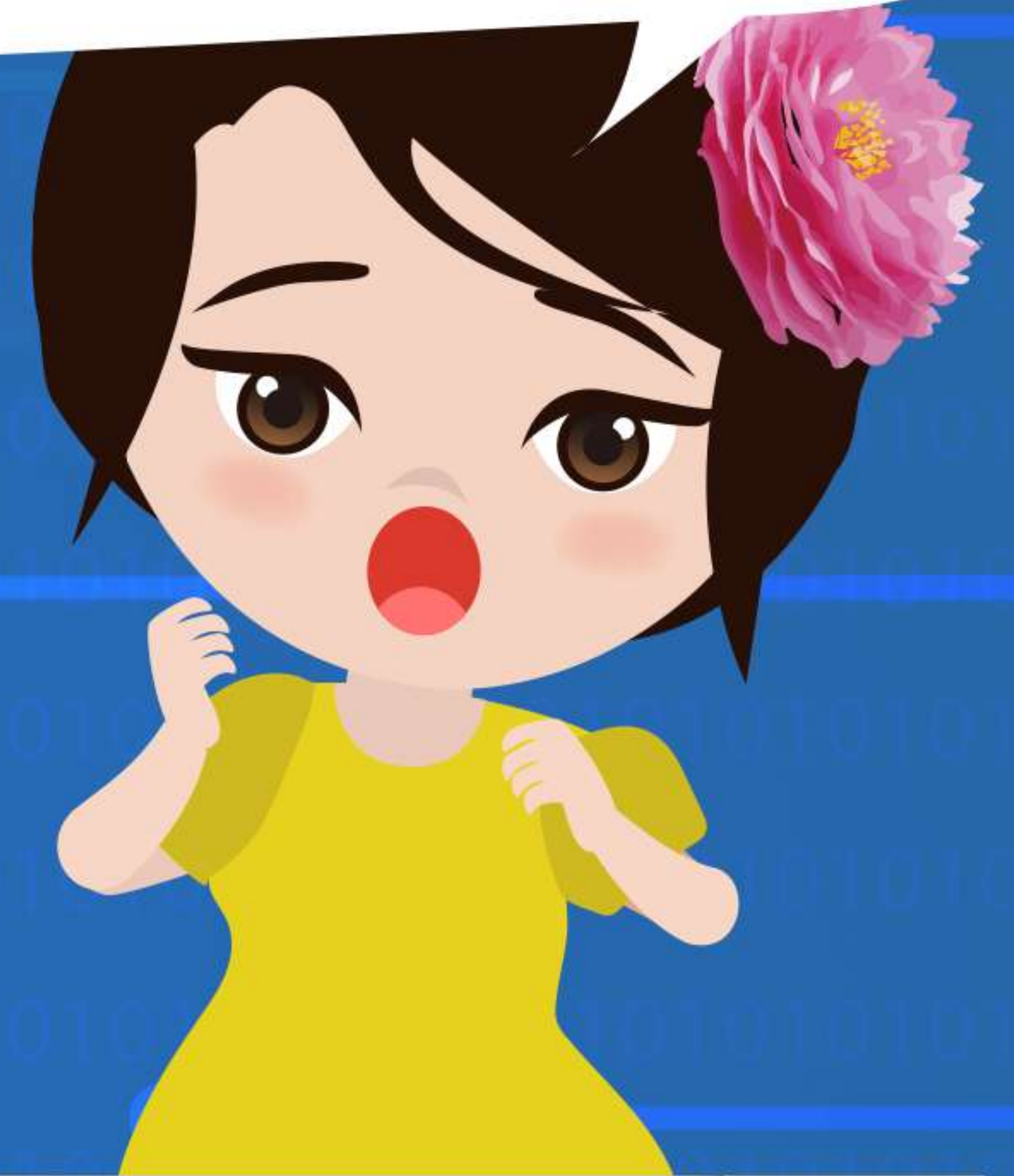

移工若有轉換雇主的需求，請務必透過合法管道媒合，以免成為求職詐騙的受害者



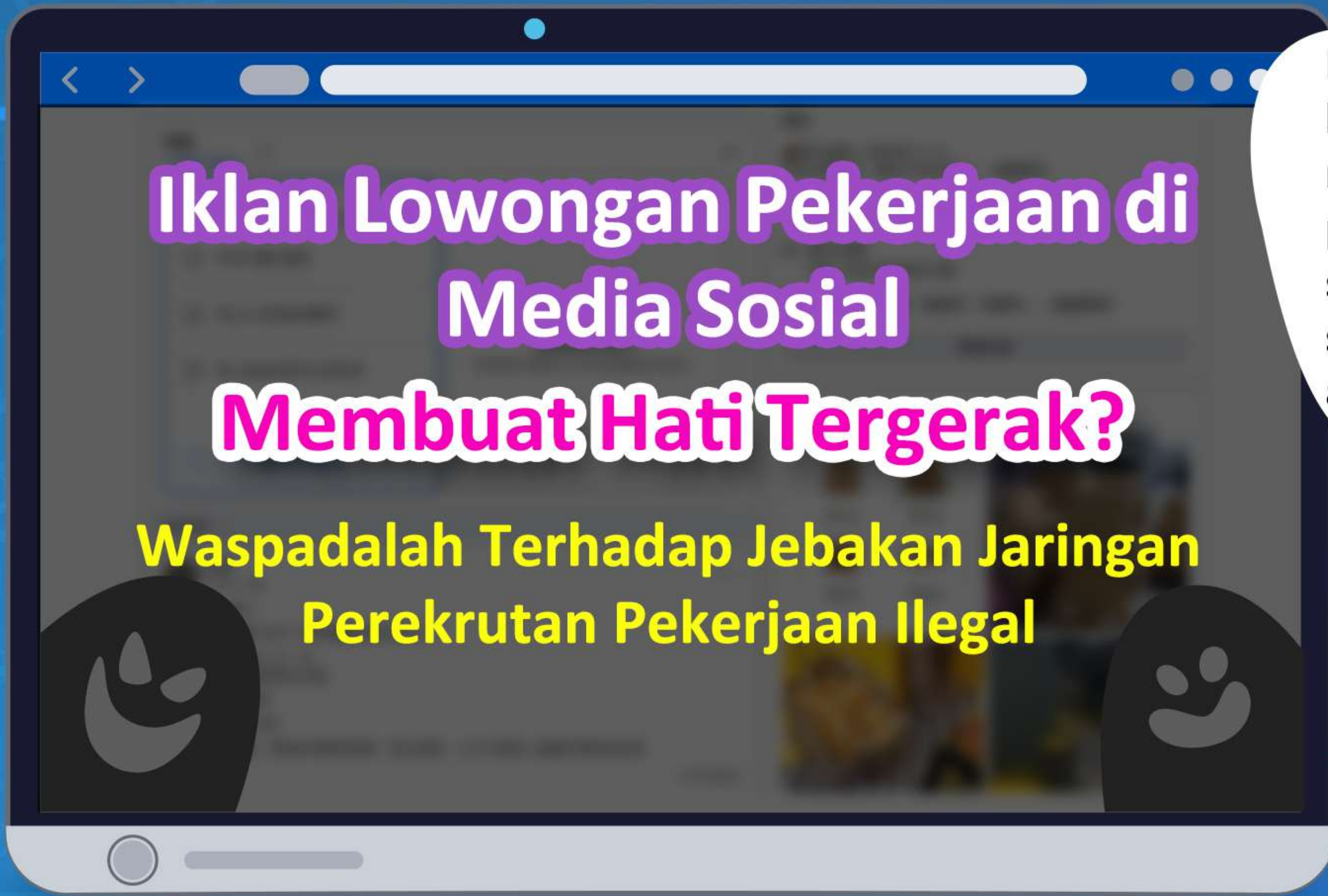
สัญญาจ้างงานของฉันใกล้ครบกำหนดแล้ว

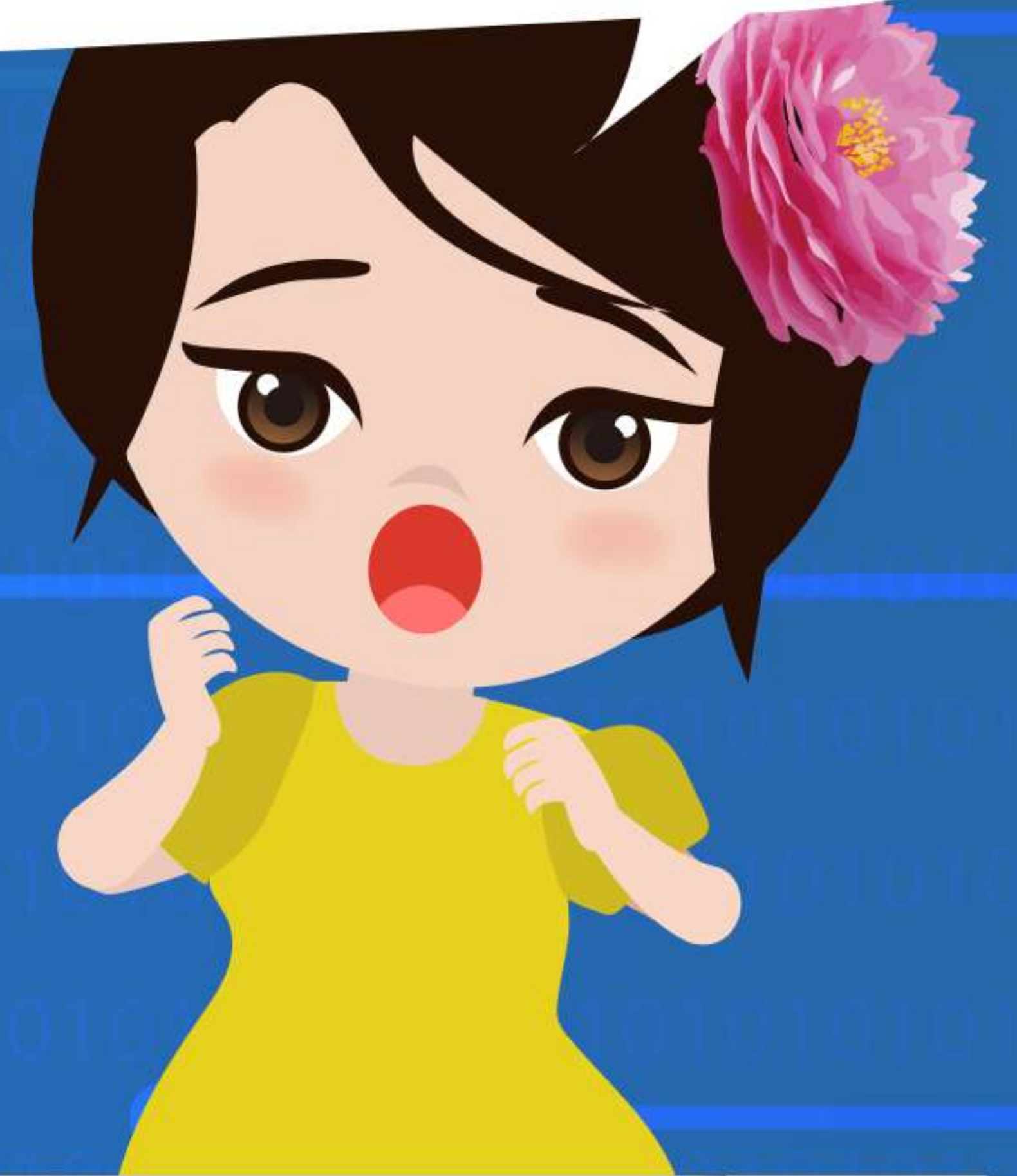

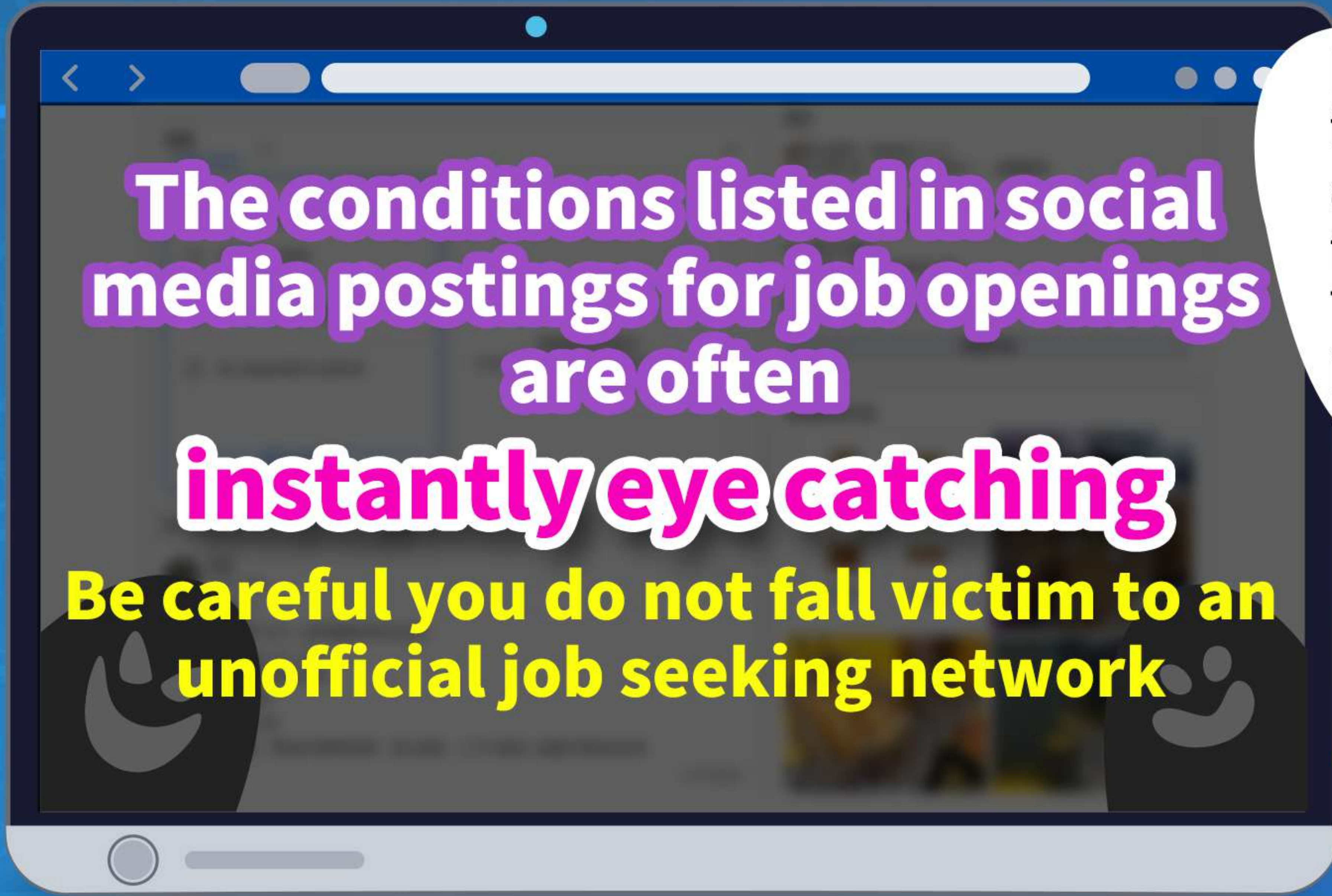

Trước đây, tôi cũng có người bạn đã hỏi về việc này và sau đó phát hiện ra rằng, **rất nhiều bài đăng tuyển dụng đều là công việc bất hợp pháp, không có giấy phép tuyển dụng!** Hãy hết sức cẩn thận khi tìm việc làm online.



**Nếu người lao động nhập cư có nhu cầu đổi chủ thì phải thông qua các kênh hợp pháp, để tránh trở thành nạn nhân của các chiêu trò lừa đảo tìm việc làm.**



My work contract is nearly up. When it finishes I want to change employers and I saw a post recruiting people on a foreign workers' social media group. The pay is great, but I'm not sure if it's real or not.



I had a friend who asked about a situation like that and he found that **in a lot of cases those recruitment posts are from people with no recruitment permit offering illegal work.** You've got to be very careful looking for work online.



**When a foreign worker wants to transfer employer, he/she should always do so through legal channels to avoid falling victim to a job offer scam.**
